



Season Pass Application – 2024

Season Passes include carts at no additional charge and allow play any week day excluding 9AM-1 PM on weekends and holidays between May 1st and September 30th.

- Playing 9AM-1 PM on weekends and holidays between May 1st and September 30th may occur but player must pay regular greens fees.

All Season Pass holders can book online Tee times up to three weeks ahead of time or one week sooner than the general public. Outings or tournaments not sponsored by Timber Trace Golf Club are not included in your golf Season Pass including the Turkey Trot Outing. Season Pass includes free access to Michigan Golden Books and Tee Time discount books to other courses as they are available.

Timber Trace Golf Club; Annual Season Pass / Season Pass Application

Season Pass holders will be subject to all Club Rules and Regulations as identified below:

1. Season Pass holder acknowledges that the entire property or a portion thereof known as Timber Trace Golf Club may be closed from time to time at the discretion of the Club for special events and/or routine or maintenance and repairs. Such events or routine maintenance and repairs will not cause the Season Pass holders to receive any additional consideration or reimbursement for the lost time and opportunity.
2. Season Pass holder agrees to hold the Club harmless for any and all injuries incurred while on the Club property.
3. Season Pass fees are not refundable and Season Pass privileges are not assignable, unless approved by the Club.
4. Season Pass holder acknowledges that an annual Season Pass is not an investment in the Club. Annual fees are pre-paid user fees, and do not create or convey a property interest of any kind, nature, right or description whatsoever in either the Club or the Club facilities.
5. Season Pass holders are expected to be supportive of the facility and be respectful to the staff. Season Pass privileges may be revoked by the Club for violation of the Clubs rules and guiding principles.
6. Personal golf carts are not allowed on the golf course without permission from the Director of Golf.
7. No personal "carry on" alcoholic beverages will be permitted. Any Season Pass holder found bringing alcoholic beverages onto the premises will have their playing privileges revoked with a pro-rated refund of previously paid fees.
8. Annual Season Passes expire November 1st or on the day the course closes whichever is later at the end of the golf season. The end of the season is determined by the club based on weather and other factors at the clubs discretion.
9. All facilities, equipment, hours, prices, services, rules, regulations and policies of the Club are subject to change at the sole discretion of the Club.
11. Ownership of a home within the Timber Trace Community (Putnam Estates) confers no Season Pass rights upon the owner of such home, nor any right to make use of the golf course or other related facilities, nor the use of a private golf cart upon Club property without previous permission.
12. Use of the Club facilities is at the sole risk of the Season Pass holder, and Season Pass holder waives any claim for loss or damage to Season Pass holder property in connection with Season Pass holder use of the facilities.
13. If a Passholder is a "NO SHOW" on a weekend morning he may lose privileges to book on a weekend without reimbursement or be responsible to pay for four golfers.
